Shawnee County COVID-19 Indicator Report and Community Update

Topeka, Kan. – The Shawnee County Health Department (SCHD) continues to closely monitor COVID-19 trends in our community. Over the last four weeks the weekly case incidence has nearly quadrupled while percent positivity and hospitalizations have tripled locally. With these increases the Community Indicator has risen to the Substantial summary index for the first time since the week of February 14, 2021.

For the last reporting period (7/11-7/17/21) weekly cases rose to 178 positive COVID-19 cases, which was higher than the number diagnosed for the entire month of June. Percent positivity also increased to 5.9%, which is above the threshold (5.0%) which indicates community spread. The last time both cases and percent positivity were this high was in mid-February. Through four days of reporting this week, 176 positive COVID-19 cases have been reported to the SCHD, indicating that numbers will likely continue to increase during the next reporting period.

These increases continue to be driven by the emergence of the Delta variant, which is 60% more contagious than previous variants. Viral sequencing has identified the Delta variant as the dominant community strain in Shawnee County, making up nearly three-quarters of all sequenced COVID-19 specimens since June 1. Early infection with the Delta variant has frequently been mistaken for allergies or a "common cold" before more significant symptoms develop later in the illness.

The vast majority of cases and hospitalizations in Shawnee County continue to be in unvaccinated individuals. In fact, Shawnee County has only documented 91 total vaccine breakthrough cases or just over 1 vaccine breakthrough case for every 1,000 fully vaccinated residents. Nearly 77,500 Shawnee County residents have completed their vaccine series, which represents 44 percent of the total population. Since the beginning of June the SCHD has identified 15 separate outbreaks in congregate settings; including long term care facilities, childcare, group living, camps, and correctional facilities. In a majority of these instances the initial source of the COVID-19 outbreak has been an unvaccinated individual bringing the virus into the facility. Additional transmission then continued within these facilities amongst unvaccinated individuals. The Shawnee County Health Officer and SCHD advise that masks be worn by all staff and any unvaccinated children and adults in these settings to stop the spread to our community's vulnerable populations.



How to use and technical notes

- 1. The Shawnee County COVID-19 Community Indicator *Report* includes six *measures* (two core and four secondary), each measuring different aspects of transmission level and impact of the SARS-CoV2 virus responsible for COVID-19. Each measure can have a value falling in one of four categories of severity: low, moderate, substantial, and high.
- 2. Cases are reported as case *counts*, for simplicity purpose. The thresholds between case categories were set using approximations of the following case *rates*:
 - a. Low: less than 57 cases/100,000 per week
 - b. Moderate: between 58 and 114 cases/100,000 per week
 - c. Substantial: between 115 and 200 cases/100,000 per week
 - d. High: more than 200 cases/100,000 per week
- 3. All thresholds between categories were set based on the best available evidence from national and state organizations, when available, as well as direct experience in Shawnee County.
- 4. The report includes an *index score*. The value of each measure contributes to the summary index score differently, depending on the category that the measure is in for that week.
 - a. Each measure in the green category = 0 points
 - b. Each measure in the yellow category = 1 point
 - c. Each measure in the orange category = 2 points
 - d. Each measure in the red category = 3 points

The core measures receive double score, because of their greater importance as measures of transmission level. The total number of points for the index score is therefore 24 (if all the indicators are red).

- 5. The index score is interpreted as follows:
 - a. Score 0 = green (low)
 - b. Score between 1 and 8: yellow (moderate)
 - c. Score between 9 and 16: orange (high)
 - d. Score between 17 and 24: red (uncontrolled)

- 6. Every week the health department will release an updated report. The report will be based on the values for each measure of the previous week. The values published in the previous week's report are also included for reference. Values are provisional and may change as information becomes available.
