## Updated COVID-19 Vaccine Booster Eligibility and Availability

**Topeka, Kan.** – The Kansas Department of Health and Environment (KDHE) today has adopted the Center for Disease Control and Prevention's (CDC) <u>updated recommendation</u> concerning the expansion of COVID-19 booster recommendations to adolescent's ages 16 and 17 released December 9, 2021.

Currently, only the Pfizer-BioNTech COVID-19 vaccine is authorized and recommended for adolescents aged 16 and 17.

The following graph outlines the differences between each authorized vaccine boost dose and the eligibility of each vaccine variety:

Eligibility	16 years of age and older	18 years of age and older	All Recipients	
Time between primary series and booster	At least 6 months	At least 6 months	At least 2 months	
Authorized Dosage	0.3mL (Full Dose)	0.25mL (Half Dose)	0.5mL (Full Dose)	

Individuals are encouraged to discuss with their medical provider any questions surrounding their eligibility for a booster dose. However, a letter or prescription from a qualified medical provider or a letter from a workplace setting will **not be required**. Individuals are encouraged to bring their CDC vaccination card as documentation of their primary vaccine series; however, this is **not required**.

Individuals may receive <u>ANY</u> authorized booster type, regardless of the primary vaccine series received.



The Shawnee County Health Department (SCHD) continues to strongly encourage residents to protect themselves by getting a COVID-19 vaccine. Many opportunities to receive a COVID-19 vaccine continue to exist in our community and can be found easily through the <u>CDC's Vaccine</u> tool.

The SCHD is offering COVID-19 vaccine boosters, in addition to other vaccines, at their immunization clinic located at 2115 SW 10<sup>th</sup> Ave, by appointment only. Individuals can call 785.251.5700 to schedule an appointment for the following hours:
